Subject: Dane County Water Quality Management Plan – Revising the Sun Prairie Urban Service Area Boundary and Environmental Corridors in the Town of Burke - Resolution CARPC No. 2017-03

Dear Mr. Steinhoff:

We have completed our review of the requested amendment to the Dane County WQM Plan revising the Sun Prairie Urban Service Area Boundary and Environmental Corridors in the Town of Burke which was submitted to the Department by the Capital Area Regional Planning Commission earlier this year. The Department hereby approves of this amendment to the Dane County Plan and the Wisconsin Areawide Water Quality Management Plan (see Resolution CARPC No. 2017-03).

The City of Sun Prairie is requesting an expansion of the Sun Prairie Urban Service Area in the Town of Burke, east of US Highway 151, west of Reiner Road, south of commercial development along Capitol Drive, and north of the Waste Management's Madison Prairie Landfill facility. The proposed amendment area adds 94.7 acres with approximately 58.8 acres of developable land and 35.9 environmental corridor acres. See table below from the CARPC.

A public hearing was held on March 9, 2017. The CARPC Commission passed a resolution recommending approval of the amendment on the same date and the request was received on March 13, 2017 (see map of the proposed amendment attached to the CARPC resolution).

This amendment is an update to the *Dane County Water Quality Management Plan* and will be forwarded to the US Environmental Protection Agency to meet the requirements of the Clean Water Act of 1987 (Public Law 92-500 as amended by Public Law 95-217), and outlined in the federal regulations 40 CFR, Part 35.

This review is an integrated analysis action under s. NR 150.20 (2) (a) 3, Wis. Adm. Code. By means of this review, the Department has complied with ch. NR 150, Wis. Adm. Code, and with s. 1.11, Stats. The approval of this plan update does not constitute approval of any other local, state, or federal permit that may be required for sewer construction or associated land development activities.

Appeal Rights:

Wisconsin statutes and administrative rules establish time periods within which requests to review Department decisions must be filed. For judicial review of a decision pursuant to sections 227.52 and 227.53, Wis. Stats., a party has 30 days after the decision is mailed, or otherwise served by the Department, to file a petition with the appropriate circuit court and serve the petition on the Department. Such a petition for judicial review must name the Department of Natural Resources as the respondent.

To request a contested case hearing pursuant to section 227.42, Wis. Stats., a party has 30 days after the decision is mailed, or otherwise served by the Department, to serve a petition for hearing on the Secretary of the Department of Natural Resources. All requests for contested case hearings must be made in accordance with section NR 2.05(5), Wis. Adm. Code, and served on the Secretary in accordance with section NR 2.03, Wis. Adm. Code. The filing of a request for a contested case hearing does not extend the 30 day period for filing a petition for judicial review.
